

# End-user License Agreement ("EULA") - Milestone XProtect Central

This End-user License Agreement is a legally binding agreement between you (either an individual or a single entity) and Milestone for the XProtect Central software product, which may include associated software components, media, printed materials, and online or electronic documentation. By installing, copying, or otherwise using the product covered by this EULA, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the product, instead you may return it, within 30 days, along with all associated material to your place of purchase for a full refund. The product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Note that the product is licensed to you, not sold. The license you have been granted is identified by the Software License Code on the License Certificate.

**Installation and Use.** Milestone hereby grants you the right to install and use the software product with the following restrictions:

1. The product may be installed on one (1) computer designated as Central Server per Software License Code.
2. The product may be installed on any number of computers designated as Central Clients per designated Central Server.
3. The product may only be used on computers running operating systems for which the product was designed.
4. The software product may only be used in connection with officially compatible Milestone software products, such as the Milestone XProtect Corporate or Enterprise products. When used together with officially compatible Milestone software products the software component may also be used together with third party components build upon the Milestone Software Development Kit.
5. The software product may only be used with as many server connections as you have purchased and registered connection licenses for under the Software License Code used by the designated Central Server.

**Copyright.** All title, including but not limited to copyrights, in and to the software product and any copies thereof are owned by Milestone. All rights not expressly granted are reserved by Milestone.

**Prohibited Use.** This license does not cover use of the product for the purpose of, or in connection with, a violation of the human rights of any person as set out in the United Nations Universal Declaration of Human Rights. Any such use is prohibited and is a material breach of this EULA causing the whole license for the product to lapse immediately without notice rendering any further use of the product unlawful.

**Registration.** The product contains technology to prevent unlicensed use of the product. Computers designated as Central Servers must be registered with their hardware (MAC) address to acquire a valid license key holding the number of licensed server connections. Failing to register the product will result in denial of service. You may also need to register the product again, if you replace computer hardware.

**No Warranties.** Milestone expressly disclaims any warranty for the product. The software product and any related documentation is provided "as is" without warranty of any kind, either express or implied, including, without limitation, the implied warranties or merchantability, fitness for a particular purpose, or non-infringement. The entire risk arising out of use or performance of the software product remains with you as the user. You are notified that the product, when used with certain equipment or other software, may enable you to perform surveillance actions and data processing which are likely to be restricted by or contrary to applicable law, including without limitation data privacy and criminal law. The sole responsibility for verification of your use against compliance with applicable law lies with you as the user.

**Limitation of Liability.** The provisions of this paragraph are in effect to the maximum extent permitted by applicable law. In no event shall Milestone or its suppliers be liable for any special, incidental, indirect, or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use the software product or the provision of or failure to provide proper support, even if Milestone has been advised of the possibility of such damages. Absent any willful misconduct or gross negligence, Milestone's entire liability under any provision of this agreement shall be limited to the amount actually paid by you for the product.

**Miscellaneous.** (a) You may make as many copies of the software product as may be necessary for backup and archival purposes. (b) You may not distribute copies of the software product to third parties.

(c) You may not reverse engineer, decompile, or disassemble any of the software product's components except to the extent permitted by applicable law which cannot be contractually waived. (d) You may permanently transfer all of your rights for this product, provided the recipient agrees to the terms of this agreement.

**Termination.** Without prejudice to any other rights, Milestone may terminate this license agreement if you fail to comply with its terms and conditions. In such event you must destroy all copies of the software product.

**Governing Law.** These License Terms and the contract between you and Milestone are governed by Danish law and the sole and proper forum for the settlement of disputes hereunder shall be the Maritime and Commercial Court of Copenhagen.
